On 30 November 2023, D.M. WENCESLAO & ASSOCIATES, INCORPORATED (the "Corporation") submitted PSE Disclosure Form 12-1 or Change in Stock Transfer Agent.

The Board of Directors of the Company shall be requested to ratify and confirm the change in the stock transfer agent of the Company from Rizal Commercial Banking Corporation – Stock Transfer Department to RCBC Trust Corporation in due course.


