On 18 March 2024, D.M. WENCESLAO & ASSOCIATES, INCORPORATED (the "Company") submitted an **amended** PSE Disclosure Form 12-1 or Change in Stock Transfer Agent.

The Company was informed by Rizal Commercial Banking Corporation – Stock Transfer Department, its current stock transfer agent, that it had transitioned to a newly established stand-alone trust corporation called RCBC Trust Corporation. As a result of such transition, Rizal Commercial Banking Corporation – Stock Transfer Department shall cease to be the

stock transfer agent of the Company and RCBC Trust Corporation shall be the new stock transfer agent of the Company.

Following the spin-off of the stock transfer business of the Trust and Investments Group of RCBC to RCBC Trust Corporation, **the Company approved the appointment of RCBC Trust Corporation effective March 27, 2024, and the termination of RCBC as the Company's stock transfer agent effective March 27, 2024, subject to compliance by RCBC Trust Corporation of regulatory requirements.**


