 Any incidents or complaints related to deforestation will be promptly investigated, with appropriate
 corrective actions and remediation measures undertaken to ensure accountability and continuous
 improvement.
- **Communication**: This policy will be communicated to all employees, contractors, and project partners to ensure full awareness, accountability, and consistent application across the organization.

Rationale

Adopting a no-deforestation policy is both an environmental responsibility and a strategic imperative for long-term value creation. Forests are indispensable for a stable climate, absorbing and storing vast amounts of carbon dioxide. Yet globally, approximately 10 million hectares of forest are lost each year, releasing about 5.6 billion tons of CO₂. By preventing deforestation in its operations, DMW avoids contributing to these emissions and supports international climate goals.

In the Philippines, one of the world's most climate-vulnerable nations, forests serve as natural defenses against extreme weather. Keeping forests intact around DMW's developments helps maintain critical ecological buffers that reduce flood risk, stabilize soils, and protect surrounding communities. Preserving forest cover strengthens climate resilience while ensuring that urban growth proceeds responsibly and sustainably.
